## **RECOGNITION OF ITALIAN CITIZENSHIP**

Please note that the following is intended as a **general guide** and that your own case may differ and require **specific evaluation**. If you have any doubts, please contact us.

Unlike Canadian citizenship, Italian citizenship depends **primarily** on the citizenship of the parents at **the time of birth of the applicant** and not on the place of birth. Italian citizenship can be passed on from one generation to the next, provided that there is no interruption due to the acquisition of some other citizenship. For example, if your paternal or maternal grandfather was an Italian citizen, your father or mother born abroad would also be considered Italian, however he/she would have to be recognised as such before your own application could be processed.

The purpose of an application for recognition of Italian citizenship is intended for those who, in fact, already are Italian citizens, but **have not yet been recognised** and registered as such.

#### AS A GENERAL RULE, YOU MAY BE ELIGIBLE FOR RECOGNITION OF ITALIAN CITIZENSHIP IF:

- you were born in Canada (or another country that grants citizenship by virtue of place of birth)
- your parent/s were Italian (or dual) citizens at the time of your birth (before January 1<sup>st</sup>, 1948 only the father could transfer citizenship, after this date both parents can)
- > you did not acquire any other citizenship before August 15<sup>th</sup>, 1992.

#### Some restrictions may apply and/or additional documents may be required.

If you are a resident of **British Columbia and Yukon** you may submit your application at the Consulate General of Italy in Vancouver. If you live somewhere else, please contact **your local Italian Consulate** (for the address please check our web-page).
